



MUDJIN FEE PROGRAM TERMS & CONDITIONS

Representing St Dominic's College commitment to the success and future pathways of our students, the Mudjin Fee Program extends beyond financial assistance. By easing the barriers to education, we strive to create an environment where Indigenous students feel valued, supported, and empowered to flourish throughout their schooling and into the next stage of life.

The 20% fee discount is made possible through government initiatives designed to strengthen Indigenous education. By aligning with this funding, St Dominic's College is able to extend additional support to families, ensuring that Indigenous students can access the full breadth of opportunities available at our College. This partnership allows us to build on our commitment to equity in education while fostering cultural connection, academic growth, and future success.

These Terms and Conditions apply to all parents/carers receiving a discount on College Tuition Fees in connection with eligible students who apply for the St Dominic's College Mudjin Fee Program for the 2026 and 2027 academic years.

A. DISCOUNT AMOUNT

A 20% discount will be applied to the College Tuition Fee. The 20% discount does not apply to the College Building Levy.

B. DISCOUNT PERIOD

Subject to these Terms and Conditions, the Discount will apply from the Discount commencement date (i.e, the day the College notifies you your child is eligible for a Discount) until the end of the 2027 academic year (Discount Period).

At the end of the Discount Period, the College may choose to continue, vary or discontinue the Discount in accordance with these Terms and Conditions. Eligible families will be notified prior to the close of the 2027 academic year.

The Discount will not be applicable to any fees due and payable prior to the Discount Commencement Date of this Offering.

C. ELIGIBILITY REQUIREMENTS

The Eligibility Requirements for the Offering are as follows:

1. The Discount is only available to new or existing enrolments of St Dominic's College.
2. To be eligible to receive a Discount, you must:
 - a. be of Aboriginal or Torres Strait Islander descent;
 - b. identify as an Aboriginal or Torres Strait Islander person
 - c. provide the required proof of eligibility and supporting documentation set out in item D.

D. REQUIRED PROOF OF ELIGIBILITY AND SUPPORTING DOCUMENTATION

Families who are eligible to receive the Discount must provide a Declaration affirming your child's Aboriginal or Torres Strait Island heritage.

This Declaration can be found within the St Dominic's College Mudgin Fee Program Application Form by clicking [here](#) or by visiting our website at www.stdominics.nsw.edu.au.

Your Declaration is a binding document demonstrating your knowledge of your child's family history and identification as an Aboriginal or Torres Strait Islander person. To strengthen your application St Dominic's College requires you to supply supporting documentation.

Supporting Documentation

The Declaration should be accompanied by supporting documentation, which might be any of the following:

- Confirmation of Aboriginality papers.
- A birth certificate indicating Aboriginal or Torres Strait Islander heritage.
- Recognition of family from an Indigenous organisation or community member.

We understand that you may have questions about the Supporting Documentation. Please contact the College for further assistance.

E. RIGHT TO REFUSE

If the College determines that your child does not meet the Eligibility Requirements the College may:

1. refuse to provide the Discount; or
2. discontinue providing the Discount during the Discount Period,

If the College refuses to provide, or discontinues, the Discount in accordance with this item E it will provide reasonable notice to you, including reasons.

F. ENROLMENT TERMS AND CONDITIONS

Any fees payable by you under the Enrolment Application may be varied or waived depending on the amount of the Discount. If any other fees are varied or waived as part of the Discount, the College will confirm this in writing to you.

G. NO REDEMPTION OR TRANSFER

The 20% Discount applies to the College Tuition Fees payable under your child's enrolment contract in the Discount Period. The Discount cannot be redeemed for credit or cash. You cannot transfer your right to the Discount to a third party.
